S.C. Code Ann. Section 58-27-865 (Supp. 2008) established a procedure for annual hearings to allow the Public Service Commission of South Carolina ("the Commission") and all interested parties to review the fuel purchasing practices and policies of the Company and for the Commission to determine if any adjustment in the fuel cost recovery mechanism is necessary and reasonable.

In order for testimony and evidence to be received from all interested parties, a public hearing will be held in the Commission's Hearing Room, Synergy Business Park, Saluda Building, 101 Executive Center Drive, Columbia, S.C. on **Thursday, August 27, 2009 at 10:30 a.m.**

Any person who wishes to participate in this matter, as a party of record with the right of cross-examination should file a Petition to Intervene in accordance with the Commission's Rules of Practice and Procedure, on or before **July 21, 2009** and indicate the amount of time required for his presentation.
