## Electric Meter Options and Charges

## Explanation of Additional Charges

**Site Visit Charge:** Duke Energy Ohio, Inc. (the Company) plans to install the interval meter with wireless communication no later than 30 days after the effective end-use customer enrollment date (scheduled meter read date when end-use customer begins electric customer choice participation). These charges are applicable if the Company is required to make additional visits to the meter site due to the inability to gain access to the meter location when replacing the existing meter with a wireless communication meter. The site visit charge will also be assessed when additional visits to the meter site are required due to the inability to gain access to the meter location for the purpose of periodically ensuring proper meter operation and accuracy.

## Terms of Agreement

I / We request the Company to provide the services as indicated on this work order and agree to pay the Company for and use same in accordance with the Company's rates, rules, terms, conditions, or regulations applicable to the service, which shall upon date of this request, or at any time during the period service is supplied, be in effect as published in the Company's schedules or future supplements, amendments, or revisions thereof lawfully filed with the Public Utilities Commission of Ohio.
